Founded in 1997, the company has since evolved to become a major provider of food testing systems and consultancy services to food companies and government agencies around the world. BioMedix's products and services are widely used in FDA and USDA inspected plants and by the Department of Defense and the Department of Commerce in the U.S.

### Turn-Key In-house Testing Laboratories

BioMedix installs complete and on-site microbiological testing systems with the mission of granting food companies the in-house capacity to conduct microbiological testing of their product samples and environmental samples in a manner that is guided by the principles of ISO 17025. These state-of-the art equipment and validated testing systems bring major benefits to food companies in the form of reduced testing cost, increased testing efficiency and most importantly, the timely generation of testing information.

#### Comprehensive Training Programs

For food companies that have chosen to set up an on-site BioMedix testing laboratory at their facilities, BioMedix provides an intensive 3-day (4 hours/day) on-site training in the use of the system, data management and guidance in the development of product and environmental sampling protocols that are specific to each plant. These in-house laboratories have the option of going through an annual or bi-annual proficiency testing program, conducted through BioMedix Laboratories (ISO 17025:2017 accredited), to systematically verify competence.

BioMedix offers application-focused training and certification programs in Basic HACCP Development, Advanced HACCP, Basic HACCP Management for Managers and Supervisors, Food Safety Management for Food Handlers, Preventive Controls for Human Food (FSPCA), Preventive Controls for Animal Food (FSPCA), Foreign Supplier Verification Programs (FSPCA) and Prerequisite Programs (GMP, SOP and SSOP) Development and Management. BioMedix also provides customized food safety assessment and consulting services to food companies in areas such as HACCP Program, Prerequisite Programs, Microbiological Risk Assessment and Regulatory Compliance.

# Sapere On-line Food Safety Management Systems

Sapere is a web-based application software that is designed to standardize the process by which HACCP decision making is made. This subscription-based service provides a food company the option of managing its food safety program on-line. This includes the capacity to develop the HACCP plan, the Prerequisite Programs and to manage the data generated by these programs, completely on-line. The secure storage of data and the efficient access to food safety information are built-in features of this service.
